## **JAVED AHMED MALIK TERMINATED BY INTERNATIONAL HUMEN RIGHT COMMISSION**

**Explained by RAFAL MARCIN WASIK SG IHRC**

London, 02.06.2019, 03:27 Time

**USPA NEWS** - By virtue of my decision resulting from the post of chairman of the IHRC's supervisory board, I received the IHRC Management Board from the right to conduct further correspondence and to make joint arrangements. From now, on 17/08/2018 at 15:00 all your contacts with IHRC can only take place on line with me and only in writing.

I hereby inform you that in my possession are documents and testimonies indicating clearly and beyond reasonable doubt for you as a person who acted with full deliberation and aware of the consequences committed numerous crimes of fraud, extortion of substantial funds and falsification of diplomatic documents. In addition, you falsely referred to influences and made false statements about allegedly owned powers on the part of the IHRC Headquarters.

In addition, you conducted these criminal activities in cooperation with other people, which clearly indicates the activities of an organized criminal group. For my part, I am ready to go immediately to Bristol to file evidence in the territorially appropriate criminal police unit and to formally prosecute against you and your associates in these crimes.

I do not conceal that it would give me great satisfaction not only because I despise you, but also to make you realize that fraud under a humanitarian organization is subject to the most severe punishment. And it was good that you conducted your criminal interests from the UK, because there the punishments for such actions are inevitable and much higher than in other parts of the world.

However, at the personal request of the Secretary General of IHRC Sir Rafał, Marcin Wasik, I am ready to give you the last chance to defend honor and freedom. Below I present the irrevocable and non-negotiable terms of our agreement, on the basis of which you and your people can remain free. I will just add, that if any of the following conditions are not met completely and / or within the prescribed time, or you do not want to maintain contact with me,

The IHRC authorities are forced to inform you that we have received further information about Mr. Javed Malik, who claims to be the chairman of the IHRC, for extortion money for the documents of our Organization. Our Organization does not charge ANY REMUNERATION for appointment in its structures.

Mr. Javed Malik does not perform any functions, the more managerial, and does not have the authority to issue or mediate in issuing any documents or appointing ambassadors in either the IHRC or any organization or company associated with it.

Mr Javed Malik was nominated by the IHRC authorities as the Chairman of his Federation, but his lack of action towards its registration made it impossible to establish it.
